BOSTON CITY COUNCILOR

Andrea Joy Campbell is member of the Boston City Council representing District 4, which includes parts of Boston's Dorchester, Mattapan, Jamaica Plain, and Roslindale neighborhoods. She was first elected to the council in November 2015 and assumed office in January 2016. On January 1, 2018, at the start of her second term, Councilor Campbell was unanimously elected Boston City Council President by her colleagues. She is the first African-American woman to serve in this role.

AWARD DESCRIPTIONS

Gideon's Trumpet Award

The Gideon's Trumpet Award was established in 2003 to honor the outstanding work of a member of the pro bono panel of VLP's Senior Partners for Justice project. The award is named after the book *Gideon's Trumpet* by Anthony Lewis, which chronicles the establishment of the right to counsel in criminal cases at all levels of the American judicial system. The award honors those striving to provide similar access to justice in civil matters.

Denis Maguire Pro Bono Award

Denis Maguire, who served as the treasurer of both the Volunteer Lawyers Project (VLP) and Boston Bar Association, personified the commitment to public interest for which Boston lawyers are noted. VLP established the Denis Maguire Pro Bono Award in 1989 to honor the work of outstanding members of its pro bono panel and to commemorate Denis Maguire's commitment to VLP and access to justice through pro bono efforts.

SETTLEMENT & EARLY RESOLUTION VOLUNTEERS (SERV)



When I was a young bankruptcy lawyer in the 1980s, I volunteered for VLP and took several pro bono Chapter 7 cases. Once I became a judge, I often volunteered to do trainings with other bankruptcy professionals for the lawyers who volunteered to represent Chapter 7 debtors. Fifteen years ago, as a bankruptcy judge in the District of Massachusetts, Judge Boroff and I

founded the court's Pro Bono Committee to encourage lawyers to do volunteer work representing debtors. From the inception, we included VLP as a member of the committee. Its representatives have made and continue to make significant contributions to the mission and projects of that committee.

When I retired as a judge in May 2019, I joined JAMS and knew I wanted to resume volunteering to help pro se parties and renew my volunteer efforts with VLP as well as to improve my mediation skills. I was aware of the leadership of Judge Ginsburg at Senior Partners for Justice and I contacted VLP and asked to volunteer for the SERV program as a conciliator in the Suffolk Probate and Family Court. Until the pandemic, I have volunteered with on Mondays helping pro se parties settle their divorce and parenting disputes.

I am honored to receive the award, particularly because I loved the book Gideon's Trumpet which inspired many young people, including me, to be a lawyer and to help the indigent.


