- The video states that MADE will generate a motion to compel discovery. This would not be filled out during the A&D clinic since you would just be filing the discovery.
- MADE will generate a motion to compel after the A&D is completed. MADE will text the CL about discovery deadlines after A&D is completed.
- A question was asked about if there is a live TRO option on MADE, but the speaker was unsure of the answer. We do not believe there is a TRO option on MADE.

- At the 1-hour mark, the video talks about changes to the housing court. It mentions that all court events are virtual via zoom, which is no longer the case. It also says court events are scheduled for discrete appointments. This has changed as well.
  - Mediations (sometimes called Tier 1) are scheduled over zoom, but all other motions are held in person. Any party can request a zoom hearing by motion; whether it is granted is up to the judge. Ideally, evidentiary hearings with witnesses should be in person, but again any party can request a zoom hearing by filing a motion.
