JUDGE EDWARD M. GINSBURG GIDEON'S TRUMPET AWARD

The Judge Edward M. Ginsburg Gideon's Trumpet Award was established in 2003 to honor the outstanding work of a member of the pro bono panel. The late Judge Edward Ginsburg, who founded Seniors Partners for Justice, named the award after the book Gideon's Trumpet by Anthony Lewis, which chronicles the establishment of the right to counsel in criminal cases at all levels of the American judicial system. The award honors those striving to provide similar access to justice in civil matters.

DENIS MAGUIRE PRO BONO AWARD

Denis Maguire, who served as the treasurer of both the Volunteer Lawyers Project (VLP) and Boston Bar Association, personified the commitment to public interest for which Boston lawyers are noted. VLP established the Denis Maguire Pro Bono Award in 1989 to honor the work of outstanding members of its pro bono panel and to commemorate Denis Maguire's commitment to VLP and access to justice through pro bono efforts.

Rontear Pendleton is currently the Deputy Attorney General at the Massachusetts Attorney General's Office. Prior to returning to the Office, Ms. Pendleton was the General Counsel at the Department of Labor Standard (DLS) where she served as the Chief Legal Advisor for the agency. Before transitioning to DLS she was the Grand Jury Director and an Assistant Attorney General for the Massachusetts Attorney General's Office where she managed the day-

to-day operations of the Special Grand Jury while investigating and prosecuting criminal matters on behalf of the Commonwealth of Massachusetts. Prior to relocating to Boston, Massachusetts, Ms. Pendleton was an Assistant District Attorney and the Deputy Division Chief of the Felony Family Violence Division at the Dallas County District Attorney's Office in Dallas, Texas, where she supervised misdemeanor and felony family violence prosecutors. During her tenure, she prosecuted over one hundred criminal offenses, including but not limited to, murder, kidnapping, robbery and various assaults. Ms. Pendleton is an alumna of the University of Massachusetts, Boston and Thurgood Marshall School of Law. She is dual licensed in the State of Texas and The Commonwealth of Massachusetts. She is a member of the Massachusetts Black Lawyers Association, Boston Bar Association, Women's Bar Association, Delta Sigma Theta Sorority, Inc., and volunteer for the Boys & Girls Club, Ready to Work Initiative. She serves as faculty for the National Association of Attorney Generals Training and the University of Massachusetts.

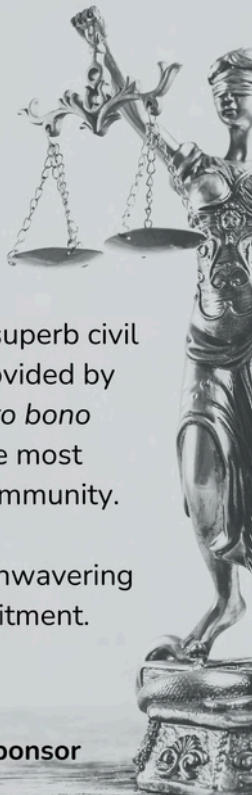

Maegan Hurley accepted her first Volunteer Lawyer Project case in 2016 and has been working on Chapter 7 Bankruptcy cases ever since. Maegan specializes in bankruptcy and runs the program at Massachusetts Debt Relief Foundation, which provides pro bono chapter 7 bankruptcy to eligible individuals in Massachusetts. There, she accepts cases from VLP and helps many individuals in their legal journey. Hurley set out to become a lawyer with the goal of helping those who most need legal representation, and through her work at MDFR and VLP, she has been able to reach that goal and impact the lives of many deserving individuals. Since starting volunteering at VLP, she has put in over 545.5 pro bono hours and has helped 95 bankruptcy clients discharge more than \$2,636,511 in debt. She shares that over the years, her clients have impacted her as well and feels consistently amazed by their resilience. Most are faced with one of the worst experiences of their lives,” she shares, “and can work

hard with extremely limited financial resources to improve their financial well-being and work towards their goals.” She shares that while her work provides debt relief that can help clients with their monthly budgets, stop court actions, and improve credit, she feels the biggest impact is made on their mental health and overall happiness, transforming their lives for the better.

Since late 2019, Julius Halstead has been involved in Volunteer Lawyer’s Project’s housing work, serving as a lead or co- counsel for multiple trials, and volunteering in the Appeals Clinic. After graduating law school, Julius was excited to delve into his legal journey and develop in private practice. He has prioritized the opportunity to spend time helping people who need it. For the past 5 years, Julius has done just that- his hard work and dedication have impacted the lives of his clients, and their perspectives have influenced his life in return. “VLP clients help me to keep perspective on society as a whole and remind me that people face very real problems every day.” He shares, “While it can be taxing emotionally, I remind myself that I have been afforded knowledge and skills to try and help them, and that’s where my power is.”

Julius has not only helped his clients reach their goals in the court room, but also find their voice and advocate for themselves, which he believes is the most important piece of his work. He recalls a case he worked on where he was able to successfully aid a tenant in a for- cause eviction bench trial; while the client and family were very thankful, what stood out to him most was how important it was to give people a chance to tell their story. “As I reflect on it, she really just needed someone to pass her the microphone, literally and figuratively, to tell her story,” he shares. Julius continues to advocate for his clients and work with them to achieve the best results. Julius is extremely honored to receive this award. We thank him for his contributions to VLP!
